How do I claim VAT relief on my order?

To claim VAT relief on your Molly Bather you will need to print out this page, fill in the VAT Exemption Form to the left, supplying your name, address and nature of your disability or illness. You will be exempted from paying VAT if you can declare that you are chronically sick or disabled.

I am unsure whether I apply?

Most of our Molly Bather users are senior citizens or disabled adults, with permanent conditions that often come in the 'autumn of our lives'.

Chronically Sick

Example conditions are: *Arthritis, Rheumatism, Heart condition etc.*

Disability

You do not have to be registered disabled to claim relief from VAT, but the nature of your disablement must be specified.

How to pay

Once you are sure of the specification you require, you will need to complete this form, ticking your choices above, completing & signing the VAT Exemption form.
